Introduction to Ngā Uruora - Kāpiti Project Inc.

Ngā Uruora - Kāpiti Project Inc. was established in 1997 by Fergus Wheeler and the Paekākāriki community to halt and reverse the decline of coastal forest on the Kāpiti – Porirua coast.

While the focus of Ngā Uruora has shifted over the past 27 years, the core activities of planting, weeding and pest control have continued. Over recent years, as other community conservation groups have formed around us, activities have become geographically constrained to a 292 hectare strip of land between Paekākāriki and Pukerua Bay.

This area contains the Paekākāriki Escarpment, recognised as an Outstanding Natural Landscape (ONL)¹ under the Resource Management Act and in accordance with the Greater Wellington Regional Policy Statement.

Within this ONL exists the Paekākāriki Escarpment Key Natural Ecosystem (KNE) which is 118 ha of land that straddles the boundary between the Kāpiti Coast District and Porirua City councils' jurisdictions². The KNE site comprises an exposed, steep coastal escarpment and contains remnant and regenerating coastal forests, grey scrub, and flaxland. The majority of the KNE site is legally protected, either by agreement between KiwiRail and the QEII National Trust, or by being within local council road reserve and recreation reserve designations.

Convenor's Report 2023/2024

This is the 8th annual report I have written as convenor for Ngā Uruora, and it is nothing short of inspiring looking back over the last 27 years that Ngā Uruora has been in existence and see everything that has been achieved.

With new members and volunteers come new ideas and enthusiasm, and I thank the committee especially for their efforts this year. One of the biggest achievements of the year at the committee level was changing banks from Westpac to Kiwibank. This was far more difficult than it should have been, but we got there in the end!

On the ground, we got the last of the major planting completed at the Waikākāriki Wetland. We will now maintain these plantings for the next few years until they achieve canopy cover and shade out most of the weeds. Unfortunately, there are a few weeds like morning glory which will require constant vigilance regardless of how established the forest becomes here.

We have also maintained a pretty good run with regular "roaming" working bees up in the hills. The majority of these have been in the Waikākāriki Gully, with a particularly enjoyable trip targeting wilding pines along the northern ridgelines of the escarpment.

Our trappers continue to great work, and we have made a commitment this year to review our pest control strategy and make some changes to ensure we are keeping up to date with best practices and technology.

And of course, the stalwarts that are the Tuesday group continue to meet on a weekly basis, with one day a month spent at the Pukerua Bay end of the track.



Kāpiti Coast Biodiversity Project

Ngā Uruora continues to benefit from being an active member of the Kāpiti Coast Biodiversity Project (KCBP).

KCBP was granted \$276,000 in 2021 by the Wellington Community Trust Climate Action Fund to undertake restoration projects in our local area. Our part of the project involves planting 2,000 enrichment species (the types of trees that would have once been common in our area such as northern rata, matai, miro and totara) and giving a boost to our Waikākāriki wetland project work.

This funding has paid for the recently installed 'Sanderson's Way' and interpretive signage and street signage at the Waikākāriki Wetland, along with a large number of plants and contractor hours to help keep weeds under control. In association with the Kāpiti-Mana branch of Forest & Bird we celebrated the 100th anniversary of the founding of Forest & Bird in 1923.

We contracted Ngā Uruora Contracting Ltd (NUCC) to prepare the Waikākāriki Wetland for planting and provide ongoing maintenance and they did a great job spraying and scrub barring weeds. Volunteers also continue to meet on a monthly basis to remove weeds.

Planting and weed control

Planting

In the previous winter season, we planted over 1000 new plants across the escarpment and Waikākāriki Wetland sites.

Paul Callister continues to supply enrichment plants and we have a big order of totara and other canopy species ready for planting Winter 2024.

We are grateful for plant donations from the restoration group at Queen Elizabeth Park. Thanks also to Te Rito Gardens and KCDC for providing the majority of our other plants.

Weed control

During the year this work included controlling climbing asparagus, English ivy, pampas, blackberry, tradescantia and boneseed control and has been undertaken by NUCC under a contract, reviewed annually. We thank NUCC for carrying out a substantial amount of extra weed control work for us free of charge.

In addition, Ngā Uruora has continued work weeding and planting at the Pukerua Bay end of the escarpment as well as controlling wilding pines and blackberry up Waikākāriki Gully and elsewhere on the Escarpment.


Thanks also to Greater Wellington Regional Council for their weed control efforts on the escarpment.

Pest control

We run a network of 255 traps and 169 bait stations, which has grown since last year.



585 pests were caught over the 2023-2024 financial year (330 the year before), with 344 rats (237), 128 mice (19), 50 weasels (37), 26 hedgehogs (19), 8 possums (0) and 9 stoats (6) and 4 cats (0). There were 2,291 trap checks over this period compared with 1,561 traps checks last financial year, a 47% increase in effort.



Thank you to Greater Wellington for continuing to supply bait and brodifacoum.
